Congress of halal quality held on May 18th and 19th 2023 in Sarajevo

Resolutions (DRAFT)

- 1. Improvement and establishment of new curricula in informal education for auditors and advisors in halal quality certification.
- 2. Accreditation of courses and lecturers, competencies and methods in accreditation.
- 3. To achieve a holistic approach to certification which, in addition to monitoring technological lines, also includes the certification of entire companies, which also means monitoring economic and financial flows.
- 4. Work to standardize certification criteria on a global level.
- 5. Developed guidance and recommendations of Halal certification for health care institutions.
- 6. Establish guidance for halal food industry dietetics according to halalopathy.
- 7. Develop a unique approach to halal certification which will embed the moral and ethical principles in terms of substance not only the form by considering a wider perspective of maqasid al'Shariah (objectives of Islamic law) in terms of implementing axioms of Islam (tawheed, vertical and horizontal justice), adalah (justice), ukhuwah (brotherhood), tezkiya (purification with growth) among others.
- 8. For gaining international recognition, integrating the halal standards is necessary into international law.
- 9. It is necessary to accept ISO standards in analyzing haram elements.
- 10. The global halal strategy should be introduced and managed globally by Muslim institutions, organizations and companies of the public, private and third sectors. The goal is to become a Global Muslim Community of Excellence (GMCE), providing continuous added value to societies. (This increases confidence in the Halal-Tayyib concept, the Halal compliance sector, the Halal ecosystem, and confidence in the GMC Global Muslim Community).
- 11. Halal leadership centers of excellence should be established globally, as leadership is critical to the success of the Global Halal Strategy.
- 12. A global corruption index system GCSI should be established: Halal is a trust. And integrity is the way to convey that to the general public. Corruption is haram and will be eradicated from the halal compliance sector.
- 13. A permanent global forum on halal integrity should be established to provide incentives to related public and private sector groups (science, business, industry, compliance sector, consumer protection, government, etc.)
- 14. A Global Halal Watch should be established to monitor transparency and fraud.
- 15. "It is recommended to invest additional efforts in the development of a "halal normative culture.
- 16. As a growing field in halal industries, halal pharmaceuticals need a focused planned halal pharmaceuticals drug information and patient counseling training for pharmacists, doctors, and other health care providers.
- 17. If there is no demand for halal pharmaceuticals because of the lack of awareness we need to create the demand. halal pharmacopeia and other halal pharmaceuticals tertiary drug information resources can play an important role in creating the demand.
- 18. Standards are the language of modern industry, the OIC/SMIIC standards cover both technical and Halal-related issues and can be the base for all Muslim countries.
- 19. It is necessary to make an agreement under the OIC on Mutual Recognition Arrangement (MRA) and Multilateral Agreement (MLA) of accreditations and certificates as soon as possible.
- 20. Diplomatic and scientific activity is suggested for realizing this idea by all congress and the OIC participants, according to International practices.
